A. Contract Amendment with California Emergency Physicians Medical Group (CEP) to fill the vacated department chair position at San Leandro Hospital for the period November 1, 2015 through October 31, 2017 (24 months) for a net increase of \$28,800. By attending and participating in Board/Committee meetings, members of the public consent to audio recording of any statements they may make during the proceedings.
