TAB #3 <u>DISCUSSION: Population Health Management</u>

Dr. Peruzzi explained that Population Health Management is a very broad concept. It circles around attending to the patient's needs at every point of their illness. The Board should understand that what we're going to embark on going forward is significant information clinical decision support and the application of knowledge. This means that we're going to have to develop a process around developing protocols for evidence based practice, getting patients the right care at the right time at the right place. This is also includes wellness education, dietary control and physical therapy.
