This area needs a multi-specialty orthopedic program and it will also create much needed revenue for the Hospital. Social media and other marketing efforts will be used from the inception of this program.

	Ms. Stebbins announced that Kerry Easthope has received a promotion to the position of Alameda Hospital's CFO. She also announced that Brian Jung is a new staff member who has been hired on as the new Chief Business Development Officer.	
	The wound care center construction is about 50% complete, which is slightly ahead of schedule. The opening is scheduled for the end of June. Interviews are in progress to fill the Medical Director position as well as nursing and clerical.	
	There are continual plans to work with outside agencies to coordinate efforts for the future of Alameda Hospital's information technology needs and overall health of the Hospital. Management is also working with local agencies such as the San Leandro Chamber of Commerce and Harbor Bay Isle Owner's Association Board to present information about our programs and future plans.
