Since January 2019, Alameda Health System has conscientiously engaged employees, providers and external stakeholders in communications informing them of program changes at the state and federal levels that had the potential to negatively impact its operations. Many of these communications also sought feedback and suggestions on expense reductions, operational efficiencies and revenue enhancements.

Attached is a compilation of many of those communication activities since the beginning of the year. The activities include meetings and written communications.

Meetings were held with the offices of elected officials at the federal, state and local level. Internal discussions included employee forums, leadership retreats and a presentation with the Committee for Interns and Residences.

Throughout the year employees have received numerous written communications, including leadership communications on the AHS intranet, systemwide and targeted (leadership and director) emails. There were also email communications to local elected offices sent to keep stakeholders informed outside of formal or regularly scheduled meetings. One important point to note is that this listing is primarily a lens into system leadership communications throughout the organization. It does not include direct communications between business units dyad leaders, department heads, and front-line manager communications with staff which would be much more exhaustive to include.
