### B. <u>INFORMATION/DISCUSSION: Human Resources Dashboard Review</u>

Tony Redmond, Chief Human Resources Officer

Mr. Redmond reviewed the presentation beginning on page 9 of the agenda packet.

The Committee discussed the potential for increased injuries such as carpal tunnel injuries because some staff work only with paper would be working only with keyboards in S\*A\*P\*P\*H\*I\*R\*E\*.

Trustee Hernandez said she still wanted voluntary and involuntary separation data differentiated. She also requested data separated by year rather than all data from 2016 to present lumped together so they could understand any changes over time. Mr. Redmond said when they used smaller data sets, there would be periods with no turn over and he wasn't sure how to show data trends for the Board's use. He confirmed he would provide the data by year, by voluntary/involuntary, and by reason going forward.

Mr. Redmond reviewed the presentation beginning on page 14 of the agenda packet.

## D. <u>INFORMATION/DISCUSSION: AHS Financial Position and Changes Being Considered That May Impact Employees</u>

Tony Redmond, Chief Human Resources Officer

Mr. Redmond reviewed the presentation beginning on page 28 of the agenda packet.

Trustee Hernandez asked about the patient care fund that the interns had recently walked out over. Mr. Redmond said the fund was being used for operational expenses and it was more efficient to capture those expenses properly rather than a fund like that.

Trustee Hernandez asked if management was working with the department level teams to determine where money could be saved. Mr. Redmond said that they had over 20 meetings around the organization to seek that feedback. He worried that some staff still was not understanding the serious nature of the budget crisis, but management has been communicating.

They discussed the options for prioritizing services and how cutting positions alone would not solve the issues.

## E. <u>INFORMATION/DISCUSSION: Update on HR Organizational Structure</u> Tony Redmond, Chief Human Resources Officer

Mr. Redmond reviewed the presentation beginning on page 33 of the agenda packet.

Trustee Hernandez discussed employee health. And how important diversity and inclusion and how they were not physically included in the slides. She said it was upsetting that there was not a formally managed program. Mr. Redmond said they could change a title to accommodate the request, but it wouldn't change anything. He

added that health equity goes beyond HR, they managed employment policies. They had to consider where or if that role exists and it would be appropriate to discuss where it belongs. Trustee Hernandez said they didn't have a dashboard on diversity and equity and they needed to do that for accountability. Trustee DeVries said he couldn't see where else that responsibility would lay if not in HR.
